Martin Jones, The Parole Board of England and Wales

Martin Jones has been Chief Executive of the Parole Board for England and Wales since 2015. Prior to 2015, Martin had spent over twenty years in a range of senior operational and policy roles in the justice system. Martin was awarded a CBE (Commander of the Order of the British Empire) for services to victims, transparency, and diversity in the justice system in 2021.

Martin has been a member of APAI since 2017, and is a huge supporter of the case for bringing different jurisdictions together to learn from each other.

When asked to share his ideas and thoughts on how we can better engage our international members, Martin said, "I think all international parole authorities should join APAI, whilst there are of course differences, there are many commonalities and huge opportunities to learn and share best practice." Further, when speaking about the value he finds in being involved in APAI he says he highly recommends attending an APAI conference, as "it is a brilliant opportunity to network and hear from high calibre speakers. Most important to me are the rich conversations that take place in and around the conference (sharing and solving our respective challenges)."

Martin's background is a key driver for me. He was born and bred in a very poor area of South-East London and was the first person to get a University Degree in his family. Arguably, his chances of being on the "wrong side" of the prison wall were higher when he was growing up than being a parole professional. He says that always gives him a sense of perspective and keeps him grounded.

We also asked Martin to share a couple goals and/or visions for parole as a whole or the field as whole, to which he had the following response, "The parole community should have two aims: 1. To dispel misinformation and misunderstanding about our roles through greater transparency and improving public awareness and 2. To focus all of our decisions on evidence and the assessment of risk."

He brings an incredible international perspective to the board and provides invaluable input on many matters across the association.
