
Among our many accomplishments listed on this page, I would like to acknowledge Catherine McVey for her tireless devotion to our survey. She, along with her team of researchers and advisors, gave our survey a depth far beyond its previous capacity. Her belief in the need and potential for the information we could provide enabled us to broaden its usefulness and expand its outreach, the latter from a Pew Center on the States grant. I want to personally thank Catherine and all who were involved for their tireless energy and enthusiasm for this hallmark work. It truly will set the standard for future research in the field.

I am pleased to have represented APAI's energy as I represented you at many national tables: the Crime and Justice Institute, ASCA Joint Executives' Meeting, CSG's Reentry Policy Forum, NIC's Development of a National Parole Framework, to name just a few.

### MAJOR FISCAL YEAR ACCOMPLISHMENTS

- **OPEN ELECTIONS** and a system of One-Member, One-Vote became a reality with the launch of our first open nominations system, including a voter validation committee and online voting.
- **MEMBER E-MAIL DATA** reached 95%, as we moved toward more efficient and effective electronic communications.
- **FIRST FRIDAY**, a monthly electronic newsletter replaced our periodic hard copy newsletter, providing current updates and a means for feedback
- **APAI'S WEBSITE** launched Knowledge Center, an instant resource of members-helping-members with questions and queries about how authorities function
- **ENHANCED FINANCIAL TRANSPARENCY AND BEST PRACTICES** accounting controls.
- **SILENT AUCTION FUND RAISER** raised \$4545, an increase of nearly 20% over last year and the largest profit ever!
- **SEVEN RESOLUTIONS** were either revised and updated or written and all were adopted by the membership
- **FOUR AUDIO CONFERENCES** were held and are archived on our website.
- **THREE TRAININGS** were held for New and Veteran Board Members as well as Key Staff Executives.
- **APAI'S ANNUAL SURVEY** emerged strong after a one-year hiatus. Participating were 47 U.S. States, 4 U.S. Federal entities and 6 International jurisdictions: Canada, Bermuda, England and Wales, New Zealand and Puerto Rico Parole Boards.

I could have never imagined where APAI's dreams would be when I took office two years ago. The reality of our accomplishments have far exceeded my dreams. For that, and on behalf of APAI, I thank all of you.
