COLLABORATION PRINCIPLES

Under the leadership of then APAI Central Regional Vice President Jeffery Peterson, and with assistance from Southern Regional Vice President Caroline Mudd and Chief Administrative Officer Keith Hardison, APAI has taken bold new steps towards forging lasting and effective collaborations between paroling and releasing authorities and their respective departments of corrections and supervising authorities. After many hours of work, a comprehensive document was prepared containing numerous strategic ideas about how this organization along with its partner organization, the Association of State Correctional Administrators (ASCA) can come along side to fulfill their common missions of protecting the public and supporting those who are daily engaged in this work. This plan was presented to the membership of APAI at its Annual Training Conference and received praise and support. The stage is now set for joint implementation planning efforts set to take place in the fall of 2011.

APAI BUSINESS PLAN

In early 2011 the Executive Committee of APAI decided to revisit and update the Association's business plan which was adopted in 2008. With planning facilitation by APAI Secretary Jeralita "Jeri" Costa and support from NIC, several planning sessions were conducted by audio and video conferencing. This ultimately led to an in person session conducted in May of 2011 in which the Executive Committee put the finishing touches on a document that will lead APAI boldly into the future.

PAROLE EXECUTIVE TRAINING

APAI Chief Administrative Officer Keith Hardison was asked to join in the efforts of NIC to develop a curriculum for the training of New Parole Executives by serving on the curriculum design committee. After several preliminary meetings with APAI member parole executives throughout the nation, a meeting of the design team was convened in Washington DC in late June. Intense work was put forth by the participants to develop an outline and suggested content for this training which is set to be unveiled in spring of 2012. This training will provide a needed resource for this often overlooked but very crucial component of the parole and release process.

NATIONAL PAROLE RESOURCE CENTER (NPRC)

As a result of APAI's partnership with the Center for Effective Policy in the National Parole Resource Center (NPRC) and with generous funding from the Bureau of Justice Assistance (BJA) many jurisdictions have been able to receive much needed technical assistance designed to improve the manner in which they go about doing their business.

Seventeen states applied to be "learning sites" in the initial round of technical assistance available from NPRC. The paroling authorities in four states, Pennsylvania, South Dakota, Connecticut and Georgia were designated to receive long term assistance as a "learning site". In two of these sites, Pennsylvania and South Dakota, the work included a focus on collaboration issues in conjunction with the paroling authority's supervision partner.

NPRC has provided or is poised to provide short term technical assistance to the parole boards in several other states including providing workshops on continuity and collaborating with partners

NPRC conducted sessions at National Reentry Resource Center Conference in February and at the APAI Annual Training Conference in May.

The NPRC web site has the most extensive collection of materials specifically designed for parole decision makers available anywhere. As of the end of June, this site had received 27,299 hits, hosted 4,281 visits, and provided 6,826 page views, with increases recorded in each category from the first to the second calendar quarter during this period.

Work has begun on a "Self-Assessment Tool Kit" designed to provide a resource to be used by parole boards, themselves, to review their practices and identify areas of strength, as well as areas in which they might need to seek assistance. Preliminary work has begun on the development of a web resource on motivational interviewing techniques.

The work of NPRC staff has documented many areas of continuing need in the field of parole decision-making. Over the course of the next year this project, through its partners, stands poised to meet these needs with continuing training and technical assistance

2011 ANNUAL TRAINING CONFERENCE

With generous support from partners at PEW and NIC, APAI hosted a successful Annual Training Conference May 15 – 18, 2011 in San Antonio, Texas.. The event was attended by approximately 130 participants including 21 participants from 7 foreign countries. Participants were given a wealth of information from highly respected practitioners and researchers in the field of parole and corrections.

We are pleased to report that this event was also successful from a financial standpoint. Due to the hard work of Chair Rissie Owens and her staff at the Texas Board of Pardons and Paroles we had overwhelming support from numerous exhibitors and sponsors. The Association realized net proceeds of almost \$26,000 from the event. This money will be used to carry on the work of the Association over the coming year.

Regional/sectional meetings were conducted for each of the five APAI regions/sections. The members of COPRA met with the Executive Committee to chart the course for the Association's future.

Back by popular demand was the meeting of parole executives and other key administrative staff. The Association also hosted a planning session of the committee using the DACUM process to develop a curriculum for the Parole Executive Training scheduled for presentation in the spring of 2012.

2011 APAI CHAIRS MEETING

This years meeting was held in Louisville, Kentucky and hosted by Chair Verman Winburn and Southern Regional Vice President, Caroline Mudd of the Kentucky Parole Board. This meeting has historically been a time for this group to get together to network and interact to discuss and solve problems that they are facing in their respective jurisdictions.. Under guidance of a highly skilled facilitator, Tom vonHemert, in addition to the peer interaction, 22 participants, including 2 from Canada heard discussion on topics such as:

APAI/ASCA COLLABORATION

On May 20, 2010 an historic meeting took place between the Executive Committees of the Association of State Corrections Executives and APAI with funding and support from NIC. This meeting came about as a result of persistence and determination on the part of President Traughber. The purpose of this meeting was to explore ways in which these two organizations could facilitate and explore improvement in the relationship between departments of corrections and parole boards, particularly and especially in those states where the two agencies are organized as a part of separate entities.

These discussions led to a set of ground breaking “ Principles of Collaboration” that will be used to guide these two sets of agencies in the future and an agreement to jointly participate in each others organizational activities. It is anticipated that his work will have a positive influence on working relationships for years to come.
