ESSENTIAL ELEMENTS

The APAI Executive Committee approved the recommendation of the APAI Standards Committee that the previous edition of the APAI Paroling Authority Standards adopted in 1995 be revised and consolidated into four **Essential Elements** of good parole practices. These “elements” consolidate the necessary attributes of a properly functioning parole decision making process into general statements that have application across a wide spectrum to parole boards and releasing authorities taking into account their differing statutory authority and operational mandates. These essential elements are:

- 1. Structure and Mission:** Releasing Authorities shall adopt written policies and procedures, reviewed and revised regularly, and open to public review. Releasing Authorities shall adopt clearly defined, easy to understand written mission statements and strategic plans, which encompass public safety and rehabilitation. Releasing Authorities shall assure that crime victims are appropriately notified and given the opportunity to provide input.
- 2. Training and Education:** Releasing Authorities shall provide initial and ongoing training for members that include a historical perspective of how and why parole was created within their respective jurisdictions. Members should understand their legal duties and authority, and adhere to a written code of ethics. Training and education should address current suggested practices, as well as enhance and strengthen skills as it relates to individual decision-making.
- 3. Incorporate Evidence Based Practices:** Releasing Authorities shall seek to incorporate practices into their operations that are proven through research to be effective in reducing recidivism. Releasing Authorities shall measure performance, and have transparent, written criteria that are considered in making release, condition setting and modification, revocation, and early termination decisions.
- 4. Engage System and Community Partners:** Releasing Authorities shall strive to enhance opportunities for offender success by collaborating with partners both within and outside of the criminal justice system, supporting the supervision of offenders in their communities, employing informal social controls, and enabling offenders to meaningfully participate in the supervision process.

As a result of APAI’s partnership with the Center for Effective Public Policy and the Urban Institute, and with generous funding from the Bureau of Justice Assistance (BJA), many jurisdictions have continued to receive much needed technical assistance and training from the National Parole Resource Center.

Work continued in four states with Connecticut, Pennsylvania, Georgia and South Dakota designated as “learning sites” by the National Parole Resource Center. This work has resulted in the publication of a document entitled *Vignettes on the National Parole Resource Center Learning Sites*, which preserve the lessons learned by these boards as they went about the business of improving their practices.

NPRC staff delivered short term technical assistance to paroling authorities in Alaska, Iowa, Kansas, Kentucky, Tennessee, Washington and Wyoming.

A two day training event entitled *Strategic Management and the Use of Evidence Based Practice for Paroling Authorities* was conducted in conjunction with the APAI Annual Training Conference in May of 2012. Members from 15 paroling authorities attended.

NPRC provided short term technical assistance to the parole boards in several other states including providing workshops on continuity and collaborating with partners. Training focused on collaboration with other criminal...

justice stakeholders and engaging those partners in a problem-solving and planning was delivered in Ohio. Training designed to bring new members onto the team, and use that opportunity to consider opportunities for strengthening practice for Boards was delivered in Iowa in March of 2012

Parole Chairs were given an update on the work of the NPRC at the APAI Chairs Meeting in September of 2011. At the May 2012 APAI Annual Training Conference a workshop was conducted entitled *Parole Interview as an Opportunity to Enhance Offender Motivation to Change*. This session was taped and will be used to provide a web based video training resource.

Work continued on a “Self-Assessment Tool Kit” designed to provide a resource to be used by parole boards to review their practices and identify areas of strength, as well as areas in which they might need to seek assistance.

2012 ANNUAL TRAINING CONFERENCE

APAI and the Florida Parole Commission, with generous support from our partners at the National Institute of Corrections, the Bureau of Justice Assistance and the National Parole Resource Center, hosted a successful Annual Training Conference May 19 – 23, 2012 in Orlando, Florida. The event was attended by approximately 139 participants including 33 participants from 18 foreign countries. Participants were given a wealth of information from highly respected practitioners and researchers in the field of parole and corrections.
