## **PROFESSIONALIZING, POSITIONING APAI IS FOCUS OF NEWEST GRANT**

**A**PAI is pleased to announce a 16-month grant of \$200,000 from the JEHT Foundation to cover designated personnel and website redesign and development. The grant, announced at our 23<sup>rd</sup> Annual Training Conference by **Bob Crane**, JEHT Foundation President, runs through June 30, 2008. "This grant," said **Lisa Holley**, APAI President, "will enable APAI to meet our immediate goals of professionalizing and positioning APAI for future growth and sustainability."

Several major projects will be initiated, including:

- A major campaign to determine who our members are and what they value in APAI. The results and analysis will enable APAI to plan for growth and provide optimal and outreach services to our members. *(See related information, p. 8)*
- A redesign and overhaul of our website, with a focus on user-friendly navigation and a broadened scope of information.
- Long-range, strategic and transparent budgets to provide a structure and plan for growth.

In his address, Crane also announced the redirection of funds that JEHT has provided to the Center for Effective Public Policy (CEPP) to create a partnership between CEPP and APAI. That partnership will enable our highly-rated and much-anticipated trainings for new board members, experienced board members and hearing officers to be scheduled in 2007. Planning will begin in mid-May, and information will be disseminated to APAI members as soon as it becomes available.

"APAI is so very grateful for the JEHT Foundation's commitment to our mission and to our future," said Holley.

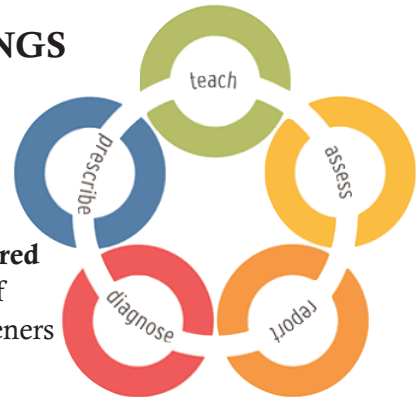

## AUDIO CONFERENCE TRAININGS IN YOUR OFFICE



**A**PAI held the fourth in a series of audio conferences on Thursday, March 8. The topic, *Principles of Mental Health and Drug Abuse Treatment for Criminal Justice Populations*, facilitated by **Fred Osher, MD**, Director of Health Systems and Services Policy, Council of State Governments. The conference attracted a record-breaking 259 listeners at 52 sites in the US and Canada.

The committee is chaired by **Cranston Mitchell**.

Sturgeon has over 35 years of experience in the criminal justice field. He is an author, teacher/trainer, practitioner, expert witness, operational content expert, and an internationally recognized criminal justice consultant.

He has received numerous awards and commendations for his work in the field of criminal justice, and has consulted for federal, state and several county governments as well as national and international corporations in the areas of management of youthful offenders, management, supervision, security, operations, special operations, emergency planning and training.

Sturgeon has co-authored two books, *No Time To Play: Youthful Offenders in Adult Correctional Systems*, (1998) and *Recess is Over: A Handbook for Managing Youthful Offenders In Adult Systems*. (2001)

He holds Bachelor of Science and Master of Arts Degrees in Criminal Justice Administration.

## INSURANCE, INCORPORATION RECOMMENDED BY LEGAL COUNCIL

Protect It!

A specialist in association law and partner in a major Chicago-based law firm, **Paula Goedert**, addressed the Executive Committee regarding some issues related to positioning APAI for the future. Among the issues were obtaining both D&O (Director's and Officer's) and general liability insurance and incorporation.

General liability can be thought of as protecting the Association entity. D&O insurance covers legal fees in the event of legal action against an association or a member based on association-related activities. D&O insurance was obtained in late March. General liability is being quoted at this time.

Incorporation protects association leaders and members against personal liability should a law suit be pressed that directly relates to their work for the association.

"It is highly unusual for an association to *not* be incorporated today, as it provides so much protection," said Goedert.

Incorporating is a fairly simple action that will require APAI to look at our bylaws. Goedert recommended eliminating some of the redundancy in our Constitution and combining that intent into the Bylaws document. To that end, **President Lisa Holley** has appointed **Garland Hunt**, Chair of the Georgia Board of Pardons & Parole who also has law credentials, to chair our Bylaws Committee.

Pursuing both insurance coverage and incorporation creates an environment in which members can step up to leadership positions with full confidence that APAI has done due diligence to protect them.
