JEHT Foundation Closes

APAI was informed on December 15 that the JEHT Foundation must close its doors. In an email, Robert Crane, President and CEO stated, "I regretfully write to inform you that due to a sudden financial crisis and the resulting loss of funding, the JEHT Foundation has stopped all grant making effective immediately and will be closing its doors in early 2009. Unfortunately the funds of the donors to the JEHT Foundation were managed by Bernard L. Madoff, a financial advisor who was arrested last week for defrauding investors out of billions of dollars. Given the circumstances, the Foundation is unable to issue any payments on unpaid grants, the unpaid portions of multi-year grants previously made, or give further consideration to any proposals that were in the pipeline."

APAI had no outstanding grants with the JEHT Foundation at the time of the announcement.

New Policy Briefing on Community Correction Strategies

A new policy brief has been issued from the Pew Public Safety Performance Project highlights community corrections strategies that can help policy makers and practitioners improve public safety and make better use of scarce public funds. [Putting Public Safety First: 13 Strategies for Successful Supervision and Reentry](#)

The 13 strategies outlined in this brief were the results of consensus findings from two meetings of national experts held over the past year by the Urban Institute, in collaboration with the National Institute of Corrections (NIC) and the JEHT Foundation.

This briefing is a companion piece to a longer [report](#) produced by the Urban Institute with the support of the JEHT Foundation, NIC and the Bureau of Justice Assistance. The report includes examples from the field and describes each of the 13 strategies in more detail.

We hope you can use this policy brief to help make the case for more cost-effective corrections in your work with policy makers and managers.

The 2009 Criminal Justice Transition Coalition, which includes The Sentencing Project and 20 other prominent national organizations, released in early November a collaborative report identifying criminal needs for federal policy reform. The report, *Smart on Crime: Recommendations for the Next Administration and Congress*, contains comprehensive policy recommendations at every stage of the justice system. For more information,
