APAI At Work

The Executive Committee met September 2 – 4 in Chicago, immediately preceding the annual Chairs' meeting. Among the highlights of the meeting were: an in-depth review of our finances, the setting of charges for each committee, and the approval of the theme for the 2009 Annual Training Conference in Newport, RI, "The Bridge to Success." This theme will represent partnerships with our colleagues in the field of corrections, public safety and the judiciary and will continue to have international representation. The 2010 Annual Conference will be in Boise, ID. There was a lengthy discussion about the 2007 Survey and the outreach of the key findings.

Tony Thompson facilitated a one-day session on the beginning of a Strategic Planning initiative that will be continued in Charlotte later this month. A review of the work completed will be in the next issue of First Friday and the complete Strategic Planning Initiative will be posted on our website.

Chairs' Meeting

The Annual Chairs' Meeting is being held this year in Chicago, September 5 – 7. Thirty-five Chairs registered and, in addition to self-directed leadership topics, will receive the training on the following topics: "Parole in the Year 2020" with Beth Oxford and Danny Hunter, Georgia Board of Pardons and Parole, and "Motivational Interviewing: Value in Risk Reduction," with Michael Guevara, NIC. The Chairs will also be invited to participate in several sessions focused on the future of APAI. The meeting is being facilitated by Tony Thompson, Professor of Clinical Law, NYU School of Law, and is being supported by NIC, Omnilink,

Behavioral Interventions (BI), Community Solutions (CSI), and Varian.
