

## **2009 APAI Award Nominations**



**Each year, we ask the APAI membership to submit nominations for the Vincent O’Leary Award, Ben Baer Award, and Community Service Award through our Web site [http://www.apaintl.org/en/aw\\_nom.html](http://www.apaintl.org/en/aw_nom.html)**

**Please note that nominations will close March 31, 2009 at 12noon EST.**

Nomination guidelines and award descriptions are listed below:

Members may make more than one nomination, via the APAI Web site; however, only one nomination may be made at a time. Do not enter multiple names in a single field next to “Nominee’s Name.”

### **Award Criteria**

#### **Vincent O’Leary Award**

The Vincent O’Leary Award recognizes an individual who has made a significant contribution to APAI and has demonstrated vision, leadership and commitment to the field of parole.

1. Nominee is a practicing or retired professional in the field of parole.
2. Nominee must have made a significant contribution to the Association and the field of parole on the local, regional, national or international level.
3. Nominee must be nominated by an active member of APAI.

#### **Ben Baer Award**

The Ben Baer Award recognizes an individual who has demonstrated a significant service in the field of parole or community corrections.

1. Nominee must be a board member, parole agent, examiner, analyst or community corrections professional who not only

has performed assigned duties in an outstanding manner, but has made a significant contribution to the parole or community corrections profession at the local, regional or national level.

2. Nominee must have brought credit or honor to the profession of parole
3. Nominee must be nominated by an active member of the APAI.

## **Community Service Award**

The Community Service Award recognizes an individual or organization which has contributed a significantly to the furthering of the rehabilitative efforts of parole.

1. Nominee is involved with the parole or community corrections system.
2. Nominee is involved in this work as a volunteer, support person, support agency or not-for-profit organization.

Recipients will be presented during our awards banquet in Newport during the Annual Training Conference Banquet on April 21st.

***Nominations from each region will be compiled by the APAI Regional Vice President for review and recommendation. Final selections will be made by APAI's President, Vice President and Secretary.***

### **Report: Minnesota Technical Release Violators –**

#### **Central Regional Vice President Jeff Peterson, Executive Officer Minnesota Department of Corrections**

As a result of the 2008 MN Legislative Session, the MN Department of Corrections was directed to submit a report by 3/1/09 to the 2009 Legislative Session in regards to Technical Release Violators.

The Report; "Review of Guidelines for Revocation of Parole and Supervised Release"; 2009 Report to the Minnesota Legislature, is our attempt to respond to the underlying premise that our revocation process results in too many Technical Violator returns to prison. We

outline our process and relate it to current best practices within a strategic approach to handling parole violations called for both within NIC's Comprehensive Framework and the PEW Center of the States nine core elements necessary for responding to release violations. We reference other national literature on this subject and incorporate actual numbers of offenders handled within our strategic approach. We conclude with recommendations for improvements and future development.

For those of you who may be interested in Minnesota's Department of Corrections revocation process and a more specific definition of Technical Violator, a term, we don't believe has served us well or the field of parole, in general, I encourage you to read the report and follow-up with me with any questions you may have, [JPeterson@doc.state.mn.us](mailto:JPeterson@doc.state.mn.us).

### **Toolkit for Second Chance Act Reentry Demonstration Project Grant Applicants**

The Council of State Governments Justice Center has developed a toolkit for state and local governments and Indian tribes interested in responding to the [solicitation for state and local reentry demonstration projects](#) released on February 27, 2009, by the Bureau of Justice Assistance (BJA), U.S. Department of Justice. The toolkit, developed with support from the [Public Welfare Foundation](#), [Annie E. Casey Foundation](#), [Joyce Foundation](#), and [Open Society Institute](#), includes materials that can help potential applicants think through the questions asked in the solicitation and design or enhance their reentry initiative. Those that are currently available are:

1. A checklist that will help state and local governments and Indian tribes meet application requirements under Section 101
