2011 APAI AWARD RECIPIENTS

Another APAI Annual Training Conference has come and gone. In addition to the many educational sessions and networking opportunities, this event is a time when we recognize those who have made outstanding contribution to our field. This year recipients exemplify the commitment and dedication that we should all strive for in our work.

James E. (Jim) Vick was awarded the Ben Bear Award. Jim has dedicated his 39 year career in the parole system to fighting for the fair and equitable treatment of offenders, providing effective re-entry programming, victims rights and the protection of the public. He was appointed Chair of the Army Clemency and Parole Board in 1981, a position

he currently holds. He is a frequent contributor to the training conferences of APAI and is an active member of this organization having served as its President from 2002 -2004

Frederick S.S. Chilukutu was awarded the Vincent O’Leary Award. Frederick is the outgoing Chair of the Zambian National Parole Board and deputy commissioner in charge of operations for the Zambia Prisons Service. DONALD A. ANDREWS, A PIONEER AND A VISIONARY

The following is an excerpt from a tribute presented at the 2011 Annual Training conference by Renée Collette, APAI International Section Vice President

When Cranston Mitchell suggested that we should pay tribute to Don Andrews who recently passed away, I could not agree more. In order to prepare myself for this moment, I read the wise words of James Bonta and I asked Jean Sutton for her input.

James reminded us that "criminology and correctional psychology lost a friend, innovator and a vigorous advocate for the just and ethical treatment of offenders".

Don met Paul Gendreau during one of his internships in the Canadian Penitentiary Service and they started to collaborate. Paul Gendreau, James Bonta and other colleagues met

regularly with Don and published two papers; the first on the "Risk-Need-Responsivity Model", and the second, a paper on the evidence that offender treatment can work if the Risk-Need-Responsivity principles are followed. In 1994, they published **The Psychology of Criminal Conduct**, now in its 5th edition. Don is the father of the risk assessment tools that we currently use in our field.

Before my arrival at the Canadian Board in 1997, the decision was made to develop a training program that would provide new parole board members with the best information available on risk assessment. To succeed, the Board needed to reach out to experts in the field. Jean Sutton put a call out to colleagues in the Canadian criminal justice system to identify who we should include on our Advisory Committee to develop this training. The

first name that came up was Don Andrews.

To quote Jean: "At this first meeting, Don cleared papers off the one available visitor's chair and I sat down to discuss the project we wanted to undertake. As I started to describe the development of risk assessment training for parole board members, Don's eyes started to dance with excitement. No longer able to contain himself he interjected by quickly identifying the type of materials that should be included in this course and the names of others who we must include on the Advisory Committee. He discussed one piece of research after another and he started bouncing around his office pulling study after study from one pile and another. It quickly became apparent that what I had viewed as messy piles of papers was Don's unique filing system. As I listened to his verbal stream of

consciousness, it also became obviously clear why everyone was saying that we should include Don on our Advisory Committee".

Those of us who had the privilege to meet Don or be trained by him could easily imagine what she described.

Jean continued by saying: "Over that next year I had the privilege to work closely with Dr. Andrews and other academics and colleagues to design the Parole Board of Canada's first training program on risk assessment. In the midst of this undertaking Don demonstrated his enormous generosity by sharing his knowledge, insight, vision, time and encouragement. His energy and enthusiasm was infectious. He never stopped being accessible and continued to provide a d v i c e a n d encouragement as we continued to refine our knowledge about risk

assessment and the training program that we had started those many years ago.”

When I arrived at the Board, I was very happy to be able to collaborate in the development of the training program for the members. Having Don Andrews on our Advisory Committee and on the

training program was a privilege. He helped us to better understand offender’s behavior with, as James Bonta described “a more scientific, more effective and more humane approach”. His research inspired us and others to follow in his footsteps and his legacy will continue to inspire many academics and

practitioners.

His generosity in always making us the beneficiaries of his knowledge and research findings has been and will continue to be an essential component of what we have to do as parole decision-makers.
